



ALL RISK CARGO FORM

To: Shippers of Motor Vehicles
RE: Insurance on your motor vehicle

Under the terms of Bill of Lading, or contract for the shipment of your privately-owned motor vehicle, the liability of VI Cargo is limited to \$500.00, if VI Cargo is responsible for the loss or damage to your motor vehicle. VI Cargo can provide you with All Risk Cargo insurance, on your vehicles less than 10 years old, at a cost of \$1.89 per \$100.00 of insured value. (*CIF = Purchase Value/Blue Book Value + Cost of Freight*). For example: the insurance premium for a motor vehicle insured a \$10,000.00 calculated invoice and freight, (CIF) would be \$189.00.

All Risk Cargo insurance will insure the motor vehicle against all risks (Act of God, fire, etc.) of physical loss or damage from any external cause excluding acts of war or terror, up to a limit of liability of the fair market value of the motor vehicle at the time of the loss. Pre-existing damage is of course excluded. We recommend that you purchase All Risks insurance on your motor vehicle either from VI Cargo, another agent or an insurance company.

PLEASE BE ADVISED THAT VI CARGO HAS NO RESPONSIBILITY FOR PERSONAL EFFECTS SHIPPED IN YOUR MOTOR VEHICLE AND CANNOT PROVIDE INSURANCE ON SUCH PERSONAL EFFECTS. PLACING PERSONAL ITEMS IN THE VEHICLE IS PROHIBITED.
